A. Background and Definitions

The Minister's Binding Policy Directive on Tuition and Anailla Fees, issued under the OCAAT Act, stipulates that certain compulsory ancillary fees that are trocheaised or new fees added only through implementation of a protocol that has beigntly agreed to by the college administration and student government representatives and approved by the board of governors;

The Student Administrative concil of Niagara College and Niagara College have had a protocol agreement since 1998 with respect to the approval of increases to the Compulsory Ancillary Fees (formerly Compulsory Non-Fuition-Related Incidental Fees).

B. Purpose

 - a) The annual deliberations of the Fee Protocol Committee will deal with proposed new fees and increases to existing "Compulsory Ancillary Fees" as outlined in the Ministry's Operating Procedures on Tuition and Ancillary Fees Reporting.
 - b) Review all "Compulsory Ancillary Fees" every five years
